Situational Awareness

[Baxter's North Cove plant](#) located in Marion, North Carolina experienced flooding from Hurricane Helene and is currently closed for production. The facility specializes in the production of intravenous (IV) and peritoneal dialysis solutions and is the leading U.S. manufacturer of these products.

The Baxter North Cove plant [restarted](#) the highest-throughput IV solutions manufacturing line at its North Cove, NC site the week of October 28, 2024 with distribution beginning in November 2024.

The American Hospital Association recommends each facility and healthcare system, in collaboration with clinical teams, incorporate their own judgement for implementing conservation strategies to manage the incident.
